NAPCO NetLink™ NL-ULBD

Transient Protection Device

INSTALLATION INSTRUCTIONS

GENERAL DESCRIPTION

The NAPCO NetLink™ NL-MOD is a device that allows the reporting of alarms over a TCP/IP based (Intranet or Internet) network. The NL-MOD is housed in a separate plastic enclosure, and although it includes electromagnetic protection (and meets direct and indirect ESD requirements for Information Technology equipment), burglary applications may call for better protection.

Therefore, the NL-ULBD was created to provide added transient protection and mounts entirely inside the NL-MOD housing. The NL-ULBD protects the NL-MOD from significantly larger transients and surges which may emanate from the network cable or associated devices. It is connected in series between the Ethernet cable that provides network access and the RJ45 connector in the NL-MOD.

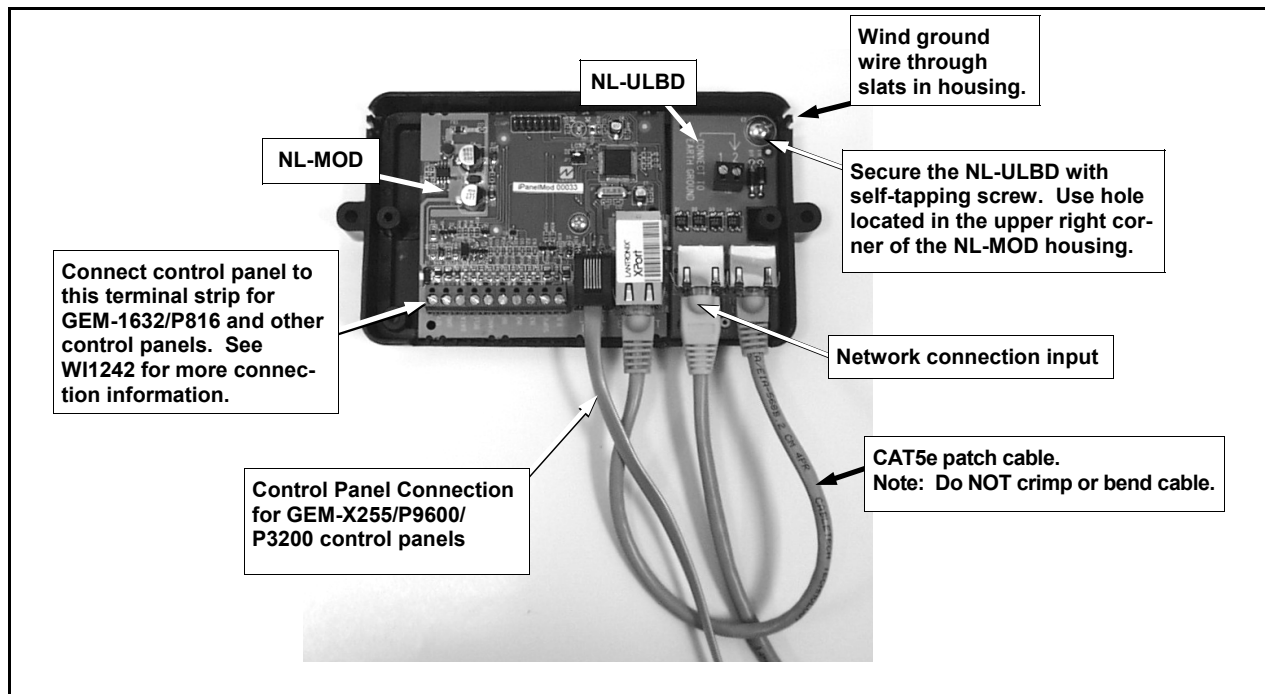
Note: For NL-MOD installation instructions, please see WI1242. Before installing the NL-ULBD, be sure to remove power to the panel, and that the installation of the NL-MOD is complete as per the WI1242 instructions.

1. **Install the NL-ULBD.** Within the NL-MOD housing, install the NL-ULBD using the self-tapping screw (supplied). Place the screw through the E2 mounting hole in the NL-ULBD and into the upper-right corner mounting hole until secure.
2. **Connect Earth Ground.** Connect a ground wire to NL-ULBD terminal 2 (marked "Connect to Earth Ground"), and

connect the other end to the *Earth Ground* mounting screw located on the control panel board (or to the same ground location to which that panel *Earth Ground* mounting screw is connected). Wind wire through vertical slats in housing (see illustration below). Be sure to use a No. 18 AWG. or larger wire to a metal cold-water pipe. Do not use a gas pipe, plastic pipe or AC ground connections. **NOTE:** Grounding connections should avoid bends in the grounding wire whenever possible.

3. **Control Panel Connections.** Connect the NL-MOD to the control panel as described in WI1242.
4. **Network Connection.** Connect the NL-ULBD to the network by connecting the network RJ45 cable into the NL-ULBD receptacle marked "To Network".
5. **Connect Patch Cable.** Connect the CAT5e patch cable (1 foot in length, supplied) into the NL-MOD RJ45 receptacle marked "Ethernet" and connect the other end into the NL-ULBD receptacle marked "To NL-MOD Ethernet Input".
Important: DO NOT crimp or bend cable. Cable must maintain a wide radius to ensure high speed data transfer. See image below.

After all connections are complete, apply power to the NL-MOD as described in WI1242.
