

# Napco T1000PIR Transmitter

#### GENERAL DESCRIPTION

The T1000PIR is a wireless PIR transmitter designed for use in Napco Super Spectrum™ wireless systems. The T1000PIR receives power from one Duracell Type DL223A 6-voit lithium battery, which can power the transmitter for 3 to 5 years. Should battery voltage drop below 5 volts, a low-battery report will be sent with any status, alarm, or test report to the receiver.

Coding switches are not used in the T1000PIR. Each transmitter has a unique factory-programmed code that distinguishes itself to the receiver. **Note:** The DIP switches and jumpers inside the unit are preset at the factory and require no further attention. (If inadvertently changed, refer to diagram silk-screened on board to restore factory settings; DIP switches are ON when right side is depressed.)



## INSTALLATION

- 1. Remove the center Lock Screw to remove the circuit board, install the battery *flat side up*, then replace the circuit board.
- 2. Press the Walk-Test Button at the top-ieft corner of the board. This will enable the Walk-Test Mode for three minutes.
- 3. Replace the front cover and place the unit face down on a bench.
- 4. Place the R1000 Receiver into the Learn Mode. Refer to R1000 installation instructions WI604.
- 5. Turn the unit over to activate the PIR. A beep at the keypad will confirm that the unit has been learned.
- 6. Mount the unit. Set the Height Scale at the right side of the board at the index in the case for the mounting height of the unit.
- 7. Walk-test the unit. Press the Walk-Test Button as needed to reactivate the 3-minute Walk-Test Mode. The LED will remain off after the Walk-Test time has elapsed.
